on the demand of any Registration Officer or Magistrate or any Police Officer not below the rank of Head constable to produce this certificate and his passport or such other proof or identify as may be required of him/his by such Magistrate or officer.

to produce, if he/she is about to deport from India his/her Certificate of Registration before the Registration Officer of the District in which his registered address is situated, obtain from him/her an endoresement of the fact that the departure report has been made and surrender his/her Certificate so endorsed to the Registration Officer of the place from which he/she propose to leave India on board a vessel or to such authority as the said officer may appoint in this behalf, and in any other case, to the Registration Officer of the district from which he commences his/her journey for the purpose of leaving India.

Provided that a foreigner who has not obtained any endorsement from the Registration Officer of the district in which he/she is Registered may in exceptional circumstances make a report of his/her intended departure to the Registration Officer of the place from which he/her proposes to leave India atleast 24 hours before his/her intended departure and obtain the endorsement from that officer to whom the Certificate of Registration should be surrendered at the time of departure.

(a) If he/she propose to be absent from his/her registered address for a continuous period of two weeks or more, full particulars of his/her itinerary including particulars of places which he/she intends to visits, the address or addresses at which he/she proposes to stay and the date on which he expects to return to his/her registered address. This

> information is required to be furnished by a foreigners before he leaves his registered address;

- (b) If he/she proposes to change his/her register address, or to leave India the particulars of his/her new address and date of proposed change or departure; and
- any circumstances which in any way affect the accuracy of any of the particulars set out of in his/her Certificate of Registration.
- (iv) If he/she stays for more than seven days at any place(other than a hotel or other premises where travellers are accommodated) in any district other than the district in which his/her registered address is situated, to report his/her presence in that other district to the Registration Officer thereof within seven days of his/her arrival.
- Failure to comply with the foregoing provisions will render the holder of his/her Certificate liable to be punished with imprisonment or fine or both.
- A foreigner whose legitimate duties in India involve inter-district touring may apply to his Registration Officer under para10(2) of the Registration of Foreigners Rules, 1939, for a travel permit valid for a specified period between specified places or areas. It will then be unnecessary for him/her to report to the Registration Officer in district other than that of his registered address as required by paragraph I (IV) above.
- 4. EXEMPTION FOR TOURISTS A foreigner registered as a tourist is exempt from making the report specified in para I (ii) (iii) and (iv) till the date specified on this certificate. He/she should surrender this certificate at the time of departure to the Registration Officer of the place from where he/she proposes to leave India or to such authority as said officer may appoint in this behalf.
